The undersigned is directed to say that one vacancy in the post of Assistant Administrative Officer in Level 07 of Pay Matrix Rs.44900-142400 (Group-B) (Gazetted) (Ministerial) in the Directorate of Extension, Ministry of Agriculture, Department of Agriculture & Cooperation, New Delhi, is required to be filled up on deputation(Including Short- term contract) **basis among the officers under the Central Government or State Government or Union Territories administrations or Statutory or Autonomous Organizations or public sector undertakings or Universities or recognized Research Institutions, possessing of the following qualifications and other requirements :-**

(a) (i) holding analogous post on regular basis in the parent cadre/department,
or

(ii) with 5 years service in the grade rendered after appointment thereto on a regular basis in the Level 06 of Pay Matrix Rs. 35400-112400 or equivalent in the parent Cadre/Department and

(b) Possessing the following educational qualification:-

(i) Graduate degree from a recognized University or Institute.

(ii) Two year's experience in Administration and Establishment work.

Note:

(a) The Departmental officers in the feeder category who are in direct line of promotion will not be eligible for consideration for appointment on deputations. Similarly, deputationists shall not be eligible for consideration for appointment by promotion.

(b) The period of deputation (including Short Term Contract) including period of deputation(including Short Term Contract) in another ex-cadre post held immediately preceding this appointment in the same or other organization or department of the Central Government shall ordinarily not to exceed three years. The maximum age limit for appointment on deputation (including Short Term Contract) shall be not exceeding 56 years as on the closing date for the receipt of applications.

- (c) For the purpose of appointment on deputation basis, the service rendered on a regular basis by an officer prior to 1st January, 2016 or the date from which the revised pay structure based on the Sixth Central Pay Commission recommendation has been extended, shall be deemed to be service rendered in the corresponding grade pay or pay scale extended based on the recommendations of the pay commission except where there has been merger of more than one pre-revised scale of pay into one grade with a common Grade Pay or Pay Scale and where this benefit will extend only for the posts for which that grade pay or pay scale is normal replacement grade without any upgradation.

The selected officer will have the option either to draw his grade pay plus deputation (duty) allowance in accordance with the Ministry of Finance instructions issued from time to time or gets his pay fixed in the scale of pay of the post in accordance with the normal duties.

It is requested that the vacancies may kindly be accorded due publicity and the applications, with details of service particulars in the enclosed proforma as per Annexure, from suitable and willing officers, along with duly attested photocopies of APARs for the last 5 years, may kindly be forwarded to the undersigned, by name within 60 days from the date of publication of this advertisement in the Employment News/Rozgar Samachar.
